This agreement of Participation and General Release of All Claims (“release”) is given by the parent or guardian (“Releasor”) of the student named below (“Participant”) or participant (if over 18 years of age) with reference to the following facts:

Background

Full Release

In consideration of the mutual promises, releases and commitments contained in this Release, and for other valuable consideration, the receipt and adequacy of which is acknowledged, the Participant and Releasor and the Party’s heirs, beneficiaries, executors, administrators, assigns and anyone claiming through or under any of the foregoing, release, indemnify and hold harmless the Released Parties, their members, directors, officers, employees and agents from any and all matters, claims, demands, damages, (specifically including attorney fees) causes of action, liabilities, controversies, and suits of every kind and nature whatsoever, foreseen or unforeseen, known and unknown, which have arisen or could arise between the Participant and Releasor as a result of the Participants’ participation in the Program.

This Release shall also include permission to use photos and video of the participant in future promotional materials for the program. This Release shall inure to the benefit of the Released Parties and their successors, and assigns.
